

COAT OF ARMS OF THE VIRGINIA STREET FAMILY.

VIRGINIA STREETS.

THE original Virginia Charter from James I., 1609, contains the names of John Streate, gentleman; John Stokely, gentleman; John Posy, gentleman; all of whom are probably ancestors of this family.

CAPT. JOHN STREET, probably descended from the intermarriage of the Street and Burch families. On his coat of arms is this history:

"The Arms of the Antient family of Street are Thus blazoned (viz.) the field Gules; Three Catherine Wheels, Or., Being impaled with the Antient Arms of Burch, whose field is azure, three flowers deliz, ermine, mantled Gules, doubled Argent as herein depicted."

Capt. John Street, b. about the beginning of the 18th century, at Bristol, Eng., was a member of the Protestant Episcopal church. Was bred to the sea. Came to Virginia in the habit of mate of a merchant vessel; was promoted to be Captain; m. HANNAH WADDY, dau. of Anthony Waddy, inspector of tobacco at a place known as Waddy's Warehouse, on the Pamunky River, New Kent Co., Virginia.

He was a merchant, and afterward purchased a plantation on the south side of Metadaquin Creek, in Hanover Co., Va., where he resided the last part of his life, acting as County Surveyor and Inspector of Tobacco at the town of New Castle.

JOHN STREET,² (John,¹) b. 1735, d. Jan. 18, 1801, Hanover Co., Va., æ. 69; m. FRANCES PARKE, dau. Capt. John Parke, of New Kent Co., Va. The mother of Gov. Goodall was also a Parke, dau., it is said, of Sir John Parke, of Putney, New Kent Co., Va. In Colonial times he held a grant from the Crown of 10,000 acres of land on the Pamunky River, and in the counties of New Kent and Hanover. Parke Goodall, a brother of Gov. Goodall, m. Mary, dau. of Joseph Hall, Mayor of London. Mrs. Street d. Mar., 1791. Both she and her husband are buried in the family burying ground. John Street served in the Revolution.

JOSEPH STREET,² (John,¹) b. Dec. 17, 1737. Volunteered in the Revolutionary War when very young, and served through the war; was at the surrender of Lord Cornwallis, at Yorktown, Va. After peace was declared he went to North Carolina and m. SALLIE TATE; afterward removed to Tennessee. He was living when Gen. Jackson was elected President, and it is said he rode on horseback to see his friend inaugurated. Mr. Street lived to be 98 years old, and his wife to be 96. Both d. in Tennessee.

ANTHONY WADDY STREET,² (John,¹) b. Oct. 16, 1741, d. Jan. 22, 1809, of apoplexy. He was b. in or near the city of Richmond, Va., either Henrico or Hanover Co. When grown he went to Petersburg, Va., and all the property he had was a pony, worth about £10 sterling, and 2s., 3d. in money. He lived in Petersburg two or three years, and moved to Lunenburg Co., Va., and soon after m. (1) SARAH (MOLLY) STOKES, dau. of David and Sarah (Montford) Stokes, a sister of Gen. Montford Stokes, of North Carolina. She d. in 1803, and he m. (2) MARY GRAY, of Lunenburg Co., Va.

In the Revolution he volunteered a private in the Continental Army, and continued in the service of his country until the close of the war; was in the bloody battle of Guilford Court House and King's Mountain, and when the war ended he was Colonel commanding a regiment.

He succeeded to the office of Sheriff of Lunenburg Co. by seniority as a Magistrate, and held the office until his death. The office (Sheriff) continued in the family uninterruptedly for fifty years. He was a member of the Protestant Episcopal church. In the old vestry book in the parish of Lunenburg, Lunenburg Co., Va., among the names of Vestrymen are "Anthony, John, and David Street."



GEN. JOSEPH MONTFORD STREET,³ (Anthony,² John,¹) b. Dec. 18, 1782, in Lunenburg Co., Virginia, d. May 5, 1840, Agency, Iowa; m. Oct. 9, 1809, at Western View, Henderson, Co., Ky., ELIZA MARIA, dau. Gen. Thomas* and Mary (Alexander) Posey. She was

^{*}Gen. Thomas Posey, born on the banks of the Potomac, Va., July 9, 1780, d. at Westwood Place, Mar. 18, 1818, æ. 68. In 1774 he took part in Lord Dunmore's expedition against the Indians; was in the battle at Point Pleasant, Oct. 10. In 1775 he was a Captain in the 7th Va. Regt., aided in defeating Dunmore at Gwynn's Island, and afterward joined Washington's army. In 1779 he took command of the 11th Va. Regt., and afterwards of a battery under Gen. Wayne. Was in the assault on Stony Point, at the surrender of Yorktown, and served in Georgia till the conclusion of peace, when he resided in Spottsylvania Co., Va. In 1793 appointed Brig. Gen. in Wayne's army for the protection of settlers in the North Western Territory. He removed to Kentucky, where he was elected to the State Senate, over which he presided from Nov. 4, 1805, to Nov. 3, 1806, and Acting Lieut. Gov. of the State. In 1812 removed to Louisiana and was elected U. S. Senator. From 1813 to 1816 he was Gov. of Indiana.—[Appleton's Enc.] He was son of John Posey, a friend and neighbor of Washington, frequently mentioned in his journals. He was Capt. in 2d Va. Regt. in the French War, 1754-56.

widow of Col. Thornton, who d. in the Revolutionary War. She b. Va., Aug. 26, 1792, d. Agency, Ia., Feb. 2, 1846.

Gen. Street went to Frankfort, Ky., early in 1800, and soon began, in connection with Mr. Wood, the publication of the Western World, a journal remembered now only in connection with the "Burr Conspiracy." He was one of the first settlers at Westwood Place, now called Shawneetown, Gallatin Co., Ill. Through Henry Clay's influence he was in 1827 appointed by John Q. Adams, Indian Agent at Prairie-du-Chien, in the Sac and Fox Agency (Winnebago). He remained in this position until his death. He lies in the old family burying ground, in the Sac and Fox Agency, between his devoted wife, the dau. of Gov. Posey, and the Peace Chief of the Sacs and Foxes, Wapello, who asked that he be laid by the side of his "father" (agent) and his tribe still make pilgrimages there from the Indian Territory.

Gen. Street was a fine old gentleman, social and genial in disposition; ha raised a large family of children, and gave all of them a better education than was usual in that day, so far West.

One day, looking at a son's handwriting, he said, "Is that the best you can do? You must learn to write; that is one thing the Streets can do well; they all write a fair hand." He also said "There never was a Street who could not make a living, and they are never very wealthy." He was Brigadier General, State Militia, Illinois.
